That little homeless black and white poodle-mix puppy had grown to become our best buddy, companion, and center of our daily lives for thirteen years. He taught us lessons in trust and steadfast affection, and made us laugh every day. Barney was so special to us that we wanted to memorialize him by establishing a perpetual fund which would serve to facilitate the protection, health and welfare of dogs and cats in Fairfield County."
