This scholarship was established in loving memory of Mollee J. Seifert in 2001. Mollee graduated from William V. Fisher Catholic High School in 1993 and Ohio State School of Cosmetology in 1995.

She was tragically killed in an automobile accident on January 2, 2000; she was 25 years old.

Mollee's parents, family and friends decided they would like her memory to live on by awarding memorial scholarships each year to graduating seniors from Fisher Catholic, Lancaster, Fairfield Union or Sheridan high schools.
