The Fairfield County Foundation is proud to sponsor the 2013 American Red Cross Community Hero Award. The Foundation has sponsored this award since its inception, 10 years ago. This year's Community Hero Award goes to Anna Gerken.

Anna has been a volunteer for the Red Cross for 64 years. She served on the board of directors in Hocking County, volunteers on the Disaster Action Team, worked as a nurse and actually drew blood for the drives in the early days of biomedical services from the Red Cross. Anna established and directed first aid stations at the Hocking County Fair.

Anna currently serves as the Volunteer Coordinator for the Hocking County Community blood drives. She is the face of the Red Cross to many and has seen changes within the organization, embracing each one. Her leadership inspires others to continue in their service to their community through the Red Cross. There is hardly a branch of the Red Cross that doesn't have Anna's mark on it. Her professional yet encouraging attitude is an inspiration to us all.

Building a Legacy: One Project at a Time

Grants provided by the Fairfield County Foundation continue to touch every corner of our community, helping organizations accomplish their goals. This month, we are featuring the Ohio Glass Museum Fund.



In an effort to support their operations, The Ohio Glass Museum Fund has been established at the Fairfield County Foundation. This fund may support the day to day operations of the museum or may be used in support of a specific project.

The Ohio Glass Museum was incorporated in 2002, and major construction began in 2004. The Museum was established to reflect the importance

of the glass making industry in the history of Lancaster and Fairfield County. Fairfield County has been home to numerous glass companies over the years. Abundant supplies of natural gas and sandstone in the area made it a logical choice for the establishment of the glass making industry. In 2003, the Ohio legislature designated Lancaster as the "Pressed Glass Capital of Ohio." New Board Member Spotlight: Dr. James Smith



Dr. James M. Smith was appointed as the dean of Ohio University Lancaster in 2010. As chief administrative and academic officer of the campus, the dean is responsible for the overall administration of the campus, including fiscal management, physical plant operations, and academic programs. Smith is the seventh dean of the Lancaster Campus and Pickerington Center.

Smith served from 2007 to 2009 as the interim dean at Bowling Green State University (BGSU) Firelands College in Huron, Ohio. While at BGSU

Firelands, he also served as the associate dean for academic programs and services, several years as an associate dean for engagement and outreach and as the applied sciences department chair.

Smith holds a Ph.D. and M.A. from the University of Maryland at College Park in industrial, technological, and occupational education with an emphasis in industrial and organizational psychology.

He has served on the Lancaster Fairfield County Chamber of Commerce, the Chamber's Education Committee, the Lancaster Festival Board, Fairfield Medical Center Community Advisory Council, and the Lancaster Rotary Club.
