Scholarship Application Process Goes Live January 1, 2015

The Fairfield County Foundation scholarship application process will go live on our website beginning Thursday, January 1, 2015. Once again we will be working with AcademicWorks, a comprehensive Scholarship Management Solution, that allows the Foundation to automatically match students with relevant scholarships. This online scholarship process makes applying for scholarships more efficient for both the students and the reviewers. The application process will be similar to last year's process. The deadline for all applications to be complete is Wednesday, April 1, 2015.

2014 Charitable IRA Rollover Ending Soon!

Congress reauthorized the IRA rollover for 2014, but this opportunity expires on December 31, 2014.

If you are 70 $\frac{1}{2}$ or older you can make a charitable gift up to \$100,000 from your IRA. Your gift will qualify for your 2014 minimum distribution and you will not have to pay federal income tax on the amount given from your IRA to the Fairfield County Foundation.

By transferring some of your IRA required minimum distribution to the Fairfield County Foundation, you can lower your taxable income. With lower taxable income, you could reduce your income and capital gains taxes this year, while also reducing your future taxable estate.
