

To celebrate our 25 year anniversary, we are inviting local non-profit organizations to participate in our 25-HOUR GIVE!

"We're honored to have reached this milestone and are truly grateful to our donors and supporters throughout Fairfield County, who make our Foundation a success," said executive director of the Fairfield County Foundation, Amy Eyman. "The 25-hour give is the perfect way for us to celebrate 25 years of building a legacy, by giving back to those organizations that support our community."

The 25-Hour Give will begin at 9 a.m. on May 1, 2014 and donations will be accepted until 5 p.m. The Give will continue from 8 a.m. to 10 a.m. on May 2, 2014.

#### How it works:

- Non-profit organizations should secure donations that must be delivered in person to the Foundation offices - 162 East Main Street, Lancaster - during the event's specified date and time.
- Qualifying organizations may receive a matching donation up to \$1,000.
- \$25,000 in matching gifts will be awarded. Dollars will be given on a first-come, first-serve basis during the event.
- All checks will need to be made payable to the Fairfield County Foundation with the non-profit of choice in the memo line.

Eligibility: Qualifying organizations must be a 501(c)3 with a physical location in Fairfield County. No government entities, schools or churches are eligible, however 501(c)3 organizations affiliated with these groups are eligible (food pantries, foundations, etc.).

# **Grant Applications Due May 12, 2014**

The spring grant deadline is on **Monday, May 12, 2014**. Grant guidelines and the grant application can be found on our <u>website</u>. 20 nonprofit organizations submitted a preliminary application by the March 10th deadline and of those, 19 organizations were invited to continue the grant process.
