Setting up a Fund with the Foundation

Your Foundation is here to help you build your legacy. We can help you determine your charitable goals, such as deciding if you want family members involved, both now and/or in the future; considering how much involvement you want in selecting the charitable organizations that will receive grants from your fund; and thinking about how much you want to give in charitable contributions each year and how you want to give it.

We make giving easy and effective, accepting a wide variety of gifts and providing donors with a number of charitable options. Our professional staff has in-depth understanding of the issues, opportunities and resources that shape our community. The Foundation has several options for setting up a fund that best meets your giving goals, including the following:

- **Donor-Advised Funds:** This type of fund enables donors or their designees to recommend grants based on their personal charitable interests.
- **Unrestricted Funds:** Unrestricted Funds are gifts to the Foundation's unrestricted general fund. The principal and income is distributed at the Foundation's discretion in the form of grants to 501(c) (3) organizations. A minimum gift of \$5,000 is required to establish a named fund. Gifts of any amount are accepted into the general fund.
- **Scholarship Funds:** Individuals, families, companies or organizations can establish Scholarship Funds. Once in place, a Scholarship Fund continues to grow with additional contributions from the original donors, from other contributions and through market growth. The donor of a Scholarship Fund has the ability to define the scholarship's advisory committee and the guidelines for candidate selection, requirements and award use.

- **Agency Funds or Endowments:** Agency Funds or Endowments can be created to perpetually support your community service agency. Agency funds hold assets for a charitable organization and distribute the principal or earned income in accordance with the agency's specific instructions.
- **Designated Funds:** Designated Funds are established to ensure that support will be provided to specific eligible non-profit organizations, often organizations that donors have been involved with during their lifetimes. This is an opportunity to leave a lasting legacy in the donor's name.

Making a Gift to the Foundation

A variety of assets can be used to make charitable gifts and there are many ways that you can give immediately or in the future.

- **Cash:** Cash gifts are an easy way to make an impact in your community and allow you to give at any time.
- **Securities:** Securities, both publicly traded and closely held, can be used to set up a fund.
- **Real and Personal Property:** Gifting real and personal property often allows an individual to contribute more than they may have thought possible.
- **IRA/Retirement/Pension Fund Assets:** Retirement assets are most often used as testamentary gifts, creating charitable funds as part of an overall estate plan.
- **Life Insurance:** Life insurance makes it possible to make meaningful gifts to the community.
- **Unique Assets:** Examples might include stamp, coin or art collections; copyrights and patents; royalties; or other unique assets of value.
- **Wills and Bequests:** Bequests offer varied ways of giving to the Foundation. Cash securities or other property may be bequeathed in one's will.





- **Charitable Remainder Trusts:** A Charitable Remainder Trust provides life-long income for one or several income beneficiaries, such as the donor and the donor's spouse, and leaves the remainder interest to the Foundation or designated beneficiary.
- **Charitable Lead Trusts:** The income generated from assets placed in a Charitable Lead Trust is paid to the Foundation for a period of years, after which the trust is terminated and the assets are returned to the donor.
- **Charitable Gift Annuities:** The Charitable Gift Annuity can make it possible for donors to assist the community in the future while providing lifetime income for themselves. Upon the death of the donor, the remaining principal is retained by the Foundation to carry out the donor's charitable intentions.
- **Transfer of a Private Foundation:** This type of gift affords many advantages, including lower overhead, staff to assist with charitable goals, and a higher tax deduction for any future gifts, to name a few.

FUNDS



Donor Advised Funds

This type of fund is one of our most appealing charitable vehicles. Donor Advised Funds make possible several options, such as: making a charitable gift now; the ability to make suggestions regarding which charities you would like to support; setting up a fund through your will/estate; and naming certain people as advisors to your fund. Donors receive both tax and philanthropic benefits in a simple format with a high degree of flexibility.

John and Marcia Baughman Family Fund – to benefit St. Mary of the Assumption Church’s (Lancaster, Ohio) special liturgical operating fund, “For the Honor of God;” the Ohio University Foundation (Athens, Ohio) via the Baughman Family Scholarship Fund at OU-L; the Fox Family Y’s (Lancaster, Ohio) Partner for Youth Fund, and the Fairfield County Foundation’s Ambassadors’ Fund.

Blue Label/One Write Fund – this fund shall be used for the purpose of benefiting the residents and organizations of Fairfield County.

Christian Stewardship – to provide financial assistance for charitable causes, not exclusively, but with emphasis on, supporting Christian-based efforts such as evangelism, missionary support, and providing for the needy both within and outside Fairfield County.

Allison Lynn Conover Memorial Fund – to assist families with ill children from Pickerington and surrounding communities; to make monetary donations to hospitals (Nationwide Children’s Hospital and The Ohio State University Pediatric Resident Scholarship Fund) and to give tangible items to the hospital to benefit patients and families that are currently residing there; and to match a dance scholarship for a student at the Judy Dollenmayer Studio of Dance.

Donley Family – distributions shall be made primarily to charitable organizations which provide services primarily in the area of Pickerington or Violet Township, Ohio.

Charles and Diana Eversole Family – to provide an ultimate benefit to the people of Fairfield County, Ohio, for public, charitable and educational purposes, with special consideration given to the Fairfield Heritage Association and matching funds to the Fairfield Medical Center Foundation.

Hubie and Jenny Eyman Memorial – to be used for public, charitable and educational purposes to provide an ultimate benefit to the residents of Fairfield County.

Lorelei and David Gibbs Family – to support charitable organizations.

Great Commission – to support charitable organizations and to further the teachings of Jesus Christ, whether local, national, or worldwide.

The Rotary Club of Lancaster-Sherman Fred & Margie Hatcher Endowment – to support the needs of the Lancaster and Fairfield County community.

Harcum Family – to provide financial assistance for charitable organizations.

Robert and Shelia Heath Memorial Fund – this fund shall be distributed for the purpose of providing support for the First Presbyterian Church of Lancaster.

Heiber Family – to be used for public, charitable and education purposes to provide an ultimate benefit to the residents of Fairfield County.

Lloyd F. and Diann L. Helber – to support charitable organizations.

Jackson Family – to provide charitable programs which will aid the children and aged of Fairfield County and Bloom Township.

David L. Johns – to be used for public, charitable and educational purposes for Fairfield County.

Jennie L. Johns – to be used for public, charitable and educational purposes to provide ultimate benefit for the people of Amanda, Ohio.

Robert C. Kalish Memorial Youth Park Program – to provide funds for summer youth camp program for fourth and fifth graders attending Liberty Union-Thurston School District or who reside in the school district, at no charge to the child.

The Magpie Fund - Maggie Grace Lyons Memorial – to provide scholarships to Fairfield County students (up to age 21) whose siblings have special needs and/or have severe medical issues. Scholarships can pay for college, camps, classes (i.e. art, music, etc.).

Jayne and Jim McGill Family – to be used for public, charitable and educational purposes to provide an ultimate benefit to the children in Fairfield County, Ohio.

Terry A. McGhee/Sally J. Grimm Community – to be used for public, charitable and educational purposes.

Mowry Family – to be used for public, charitable and educational purposes to provide an ultimate benefit to the people of Fairfield County.

Ninety One: One Foundation Fund – for the purpose of benefiting the residents and organizations of Fairfield County.

Norman Family – for public, charitable and educational programs that will benefit projects in and for the people of Fairfield County.

Joe Ogilvie Fund – to benefit Duke University, The Inner City Educational Foundation, and grants for educational endeavors in Fairfield County and elsewhere.

Laurn “Lu” Oliphant Memorial Fund – to provide grants to benefit the residents of Fairfield County or those organizations supported by the Donors and/or to award scholarships to students graduating from Pickerington High School, Pickerington, Ohio.

Pickering Family – to provide funds for charitable purposes in Fairfield County.

Rodenbaugh Family – to provide funds for charitable purposes.

Wayne Roller Memorial Fund – to provide support for grants and scholarships for students, athletes, coaches, teams and officials.

Michael D. Sewell Memorial Fund – for support of the Pickerington Fine Arts programs and local arts groups, limiting help to the state of Ohio, unless a special need is discussed and voted on by the Board of Directors of the Michael D. Sewell Memorial Fund.

Wanda Shaner Memorial – to provide grants and/or scholarships to benefit the residents in Fairfield County.

Brian Stoner Memorial – to provide funds to charitable organizations that are eligible to receive distributions. Preference for grants may be given to organizations dealing with individuals with special needs. Preference for scholarships may be given to students attending culinary school and/or students who have been diagnosed as being on the autism spectrum.

Rich & Delores Troup Family – to provide funds for charitable purposes in Fairfield County.

Vonnie Cares Community Impact Fund – to provide grants to Fairfield County High School students who have a GPA of 3.0 or higher for the purpose of funding a community project to strengthen community relations, to encourage giving and recognize the kindness of others.

John and Jamie Weaver Fund – to make grants to Charitable Organizations for the purpose of benefiting the residents of Fairfield County and other charitable causes.

Williamson Family – to provide funds for charitable purposes.

Scholarship Funds

Scholarship funds help students pursue their academic goals. The donor may define the guidelines for the recipient, the advisory committee, the school and the award itself.

Matthew Acton – to provide scholarships for senior golf athletes of any Fairfield County High School, Canal Winchester High School, Circleville High School, Logan Elm High School or Teays Valley High School. This scholarship is for any accredited college or vocational school.

The Anderson/Black/Community (ABC) Mini-Scholarship – to provide scholarships to two Bloom Carroll High School students, staff members, administrators, or retired staff members who had five years of service to the Bloom-Carroll Local School District to fund a Christian Mission Trip (CMT) or a Christian Mission Project (CMP).

Roger Anderson – for students residing in Jackson Township of Perry County and majoring in education or business.

The Aranda Notre Dame Law School – to provide scholarships to students who have been accepted to the Notre Dame Law School.

James L. Barrett, M.D. – to provide scholarship assistance to graduates of a Fairfield County High Schools to attend the University of Cincinnati and major in computer science, geology, physics, chemistry, or mathematics.

Paul D. Beck – to provide scholarships for graduates of a Fairfield County, Ohio high school who demonstrate academic ability and maintain a 3.5 GPA in high school and a 3.0 GPA in any undergraduate program.

Bloom-Carroll Alumni Scholar Athlete – for Bloom-Carroll graduates who participate in sports and also demonstrate academic excellence.

William W. Bolsen Memorial – to provide scholarships for graduates of the Ohio State School for the Blind who wish to work toward a degree from a technical, two-year or four-year college.

Marlowe Brainard – to provide a scholarship for students graduating from Millersport High School who desire to continue their education in the field of Arts or Education.

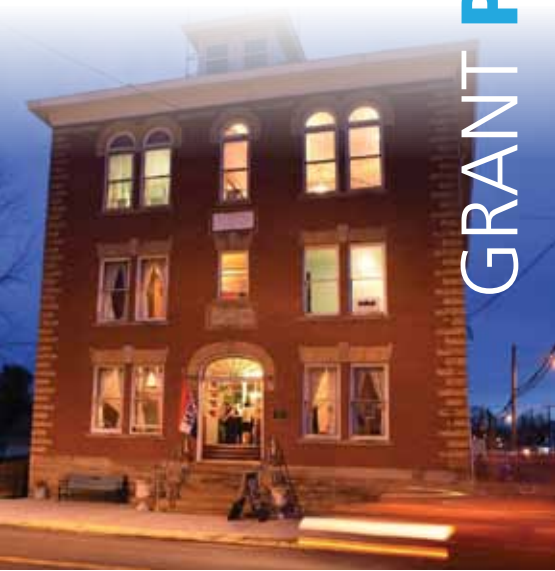
Jean M. Burdette Memorial – for Lancaster High School graduates for study in the field of Special Education.

James Caple – to provide scholarships for post-secondary studies for Fairfield County residents who pursue a course of study in classical vocal or instrumental performance.

Robert E. & Marion A. Carr – for Fairfield County residents who are pursuing a degree in the study of Nursing and/or Teaching/Education.

Molly Ann Clark Memorial – for the purpose of providing educational scholarships for students between the ages of 17-21 who are from Fairfield, Perry, Pickaway, Hocking, Licking, Athens or Muskingum county. They must demonstrate an interest in community service and volunteerism; be a past participant (racer) of the Lancaster Soap Box Derby, past Derby queen or have had a family member who either volunteered or served on the board of directors of the Lancaster Soap Box Derby. Applicants meeting the above criteria will be given preference in determining recipients, or a student seeking a degree in substance abuse education may be accepted every even year.

HVAC System Creates New Opportunities for Opera House

The Victoria Opera House, built in 1905, is a local treasure used for concerts, special events and a variety of unique programs. Unfortunately, the building's heating system is broken and it has never had air conditioning, limiting its use during the cold and very hot seasons.

Thanks to two recent grants of \$20,000, one from the Wendell Family Fund and one from the Edward N. Sands Fund for Baltimore, the Baltimore Downtown Restoration Committee has purchased a new HVAC system, which will be installed in the Victoria Opera House during the summer of 2018. This will allow the facility to be utilized year-round, providing opportunities for additional programming and family-friendly events as well as opportunities for community members to use the space for personal events like music recitals, weddings, graduation parties, etc.

"We are so excited to get our new HVAC system installed and have the ability to use the Victoria Opera House throughout the year," said Judith Cosgray, Director of the Baltimore Downtown Restoration Committee. "The Fairfield County Foundation is a catalyst for so many great things throughout the county. I encourage all local non-profits to think about how the Foundation might be able to help them fulfill their unique needs."





Charles C. & Barbara Claypool – for students seeking educational opportunities in technical fields with a preference toward engineering. Preference given to the children of employees of Claypool Electric Inc. and students planning to attend Ohio Northern University.

Deputy Ethan Collins – to provide scholarships for Fairfield County students to attend an accredited school or academy in preparation for a career in Law Enforcement or continuing education in Law Enforcement.

Coney Memorial – for Fairfield Union High School graduates.

Susie McMackin Crook – will be awarded to a student who has registered and been accepted at Lancaster Montessori School.

D.A.R.E. – scholarship recipient shall be a graduating senior from Lancaster High School, William V. Fisher Catholic High School or Fairfield Christian Academy and a graduate of the D.A.R.E. Program who desires to continue his or her education.

Davidson-J.C. Community Service – to provide scholarships to students of Fairfield County, Jaycees and relatives of current or former Jaycees will be given preference in determining recipients.

Jillian Davidson Memorial – this fund was established by family and friends to honor the memory of Jillian Leigh Davidson who died of a rare blood disease in September 2000. This scholarship is awarded to a female senior basketball or volleyball athlete at Lancaster High School. This award is given to the individual selected by the Davidson Scholarship Committee.

Elsie R. McClelland Davis Memorial – for graduates of Amanda-Clearcreek High School.

Jim DePietro Scholarship – for the purpose of providing educational scholarships for college students in the manner described: 1. Applicant must be a high school senior and a Lancaster Y Swim Team (LYST) swimmer. 2. LYST swimmer must have been a participant of the LYST program for at least two years, prior to application. 3. Seniors wishing to apply will be asked to write an essay, using an essay prompt determined by the (active) LYST Parent Board Committee.

Frank Dillard Memorial/Standing Stone National Bank – for graduates of Fairfield County High Schools. Preference given to biological or legally adopted dependents of Standing Stone National Bank employees. Weighted toward those who plan to major in Business/ Finance at Ohio University Lancaster.

Charles E. Dupler – to provide financial assistance to Fairfield Union High School music and F.F.A. students.

Chad Edwards Memorial – to provide scholarships for Fairfield County students to attend an accredited school or academy in preparation for a career in law enforcement or to further their career in law enforcement.

Leroy and Bernice Ellinger Memorial – for any graduate of a Fairfield County high school or any graduate from a high school in Worthington, Ohio. Preference will be given to a graduate of Lancaster High School. Applicant must be a college junior or senior and preference given to an accredited four-year college. Recipient must have at least a 2.75 GPA going into their junior year. There will be one award of \$4,000.

Fairfield County Educational Service Center Superintendent's Scholarship – for students within Fairfield County based on academic achievement and school activities.

Fairfield Federal Ron Keaton – to provide scholarships for Lancaster High School senior varsity girls basketball players.

Amelia Fickel - Glenn Moodie – to provide scholarships for graduates of Perry-Southern Local School District. Special consideration given to graduates who are residents of the former New Straitsville School District. Selection shall be based on financial need. May be awarded for a four-year, two-year vocational or technical college education.

Wilfred and Una Fosnaugh Scholarship Fund – this fund was established in 2005 for residents of Fairfield County, Ohio pursuing a bachelor degree in Education at any accredited educational institution and is need based.

Lynn and Lynda Freisner Fund – to award a scholarship annually to any student, Freshman through Graduate level, but only awarded for a single year for each student. Recipient must be a resident of Rushcreek Township or a member of Bremen Bethel Presbyterian Church (BBPC). In addition, recipient must be attending either The Ohio State University or Ohio University.

Lorelei Owen Gibbs – for residents of Fairfield County pursuing a university degree in Elementary education or Nursing.

The Jack Greathouse Gale Force Basketball Scholarship Fund – to provide educational scholarships for Lancaster High School seniors who were boy's basketball players.

O.J. Green Memorial – to be used to provide scholarships to the most inspirational senior football player and to one senior Art student at Canal Winchester High School.

Robert V. Grilli Memorial – to provide a scholarship for graduates of Lancaster High School and Fisher Catholic High School who desire to continue their education in a collegiate and/or graduate institution.

Patricia Woodyard Gilmore Memorial Scholarship Fund – to provide educational scholarships for students who have graduated from a high school in Fairfield County and plan to attend a 4-year college or trade school program in Ohio.

Jacob Guisinger Memorial – to provide a scholarship for a graduate of Berne Union High School, a pay-to-participate scholarship for a Berne Union High School Football player, a scholarship for the Fairfield County Youth Baseball or a scholarship for the Fairfield County Youth Football participant.

Nils Gustavson Scholars Athlete – for the purpose of providing educational scholarships for a senior graduate of Lancaster High School with good academic standing and qualities of a scholar athlete. Student must attend an Ohio school.

J. Jay Hampson – for students residing in Fairfield County and attending Ohio Northern University.

Doug Henwood Memorial – to provide scholarships to Lancaster High School graduates who participate in Track and Field and may be involved in Track and Field at the collegiate level.

William D. Hilyard Family – to be used to reward the outstanding senior music student of Fairfield Union High School. The award shall be known as the "Robert Trocchia Outstanding Music Student Award" given by the Family of William D. Hilyard.

Hocking Valley Dental Society Fund – to provide scholarships for students in Dental Hygiene or Expanded Function Dental Assisting. Students must be a graduate of a high school within the counties served by the Hocking Valley Dental Society (HVDS), Fairfield, Perry, Hocking and Athens, or a resident of one of these counties, or, an employee of a dentist in the HVDS.

Billy J. Holbrook Memorial – for the non-typical Liberty Union High School graduates.

Home School – for the purpose of providing educational scholarships for home schooled students applying to attend a 2 or 4-year college.

Henry and Eleanor Hood Fund – to provide scholarship(s) to Fairfield County residents who are graduates of Lancaster High School, have completed the LHS STEM program, have been admitted to an accredited 4-year college or university with the intent to major in Engineering or Bio Medical Sciences.

Joseph and P.J. Hoover Family Trust – this fund is for the purpose of providing an educational scholarship for graduates of Fairfield Union High School for the study of art education or early childhood education.

Hutton Family Scholarship – for the purpose of providing educational scholarships for the study of Nursing. The recipient shall be entering at least their Junior or Senior (year) in college and shall be a resident of Fairfield County.

Johns Family – for graduates of Amanda-Clearcreek High School.

Trevor and Violet Jones Memorial – for graduates of Millersport High School.

The Carolyn L. Joos Memorial Scholarship Fund – for an academic scholarship for Fisher Catholic High School students.

Corey Kissing Memorial – for graduating seniors, in college preparation program of Logan High School who will attend a two-year or four-year college/university program.

Robert Knisley Fire Service – for graduates of a Fairfield County high school who want to pursue a career in the fire service and are attending a college pursuing a fire science degree or a vocational school pursuing a state of Ohio certification in a fire or EMS field. Children of present/former Lancaster Fire Department members will be given preference and can be graduates of any high school.

Keith A. Kumler Vocational – for Fairfield County students to attend an accredited vocational or technical school for study in the automotive field.

Lancaster Camp Ground Quality of Life – to provide financial support for the purpose of improving the quality of life for residents living on the Lancaster Camp Ground. The fund will offer assistance and help to defray costs in the following areas: Youth camps such as, but not limited to, church, 4-H, Boy and Girl Scouts, spiritual retreats, mission work and family camps. Life enrichment experiences for seniors 55 and older.

Lancaster-Fairfield Chamber of Commerce – for students graduating from a Fairfield County high school.

Lancaster High School Band Boosters – music scholarship for students graduating from Lancaster High School and who have been members of the Lancaster High School Instrumental Music Program.

Lancaster High School Class of 1957 Memorial – to provide educational scholarships for Lancaster High School graduates. Recipient must be currently enrolled in or have been accepted into a program leading to a bachelor or associate degree, demonstrate potential for high school or post high academic achievement and show financial need.

Lancaster High School Class of 1959 – this scholarship is for a senior graduate of Lancaster High School. 1. Recipient must not be a recipient of any other scholarship. FCF will confirm with LHS Guidance Department before actual selection of recipient. 2. Recipient must be attending any post-secondary education program and/or a traditional four-year college. This could include: community college, liberal arts college, universities, vocational schools, trade schools, institutes of technology or professional schools. 3. Recipient must be a student who, in the committee's opinion, deserves assistance, even though they have not qualified for other scholarships. 4. Recipient should be involved in school and community activities.

Lancaster High School Class of 1964 – to provide educational scholarships for a senior graduate of Lancaster High School. Recipient must not be a recipient of any other scholarship at the time of application. Recipient must be attending any post-secondary education program and/or a traditional four-year college. This could include: community college, liberal arts college, universities, vocational schools, trade schools, institutes of technology or professional schools. Recipient must be a student who, in the committee's opinion, deserves assistance, even though they haven't qualified for other scholarships. Recipient should be involved in school and community activities.

Lancaster Junior Women's Club – for the purpose of providing educational scholarships to support high school females, in Lancaster, entering their freshman year in an undergraduate college or university program who volunteer in their community, in the following manner: Female living and attending high school in the city of Lancaster who are already accepted into an undergraduate degree program for the academic year immediately following completing their high school diploma. This would include home-schooled or any traditional high school program. Cumulative GPA of 3.5 or higher on a 4.0 scale. Volunteers for a certified 501(c)3 organization for a minimum 20 hours in the prior 12 months from submitting the application.

Lancaster Kiwanis Club – for students graduating from a high school located in Fairfield County, Ohio, or to graduates of a high school located in Fairfield County, Ohio.

Erik J. Landis Memorial – to provide scholarships for graduating seniors from Fairfield Union High School.

Jamey Landis Memorial – to provide scholarships to Fairfield County High School seniors who are participating in track, cross country or FFA.

Malinda Lifer – for recent graduates of Bloom-Carroll High School or Lancaster High School who plan to major in elementary education at Ohio University Lancaster.

Frank P. Maguire Scholarship Fund – to provide scholarships to students who graduate from a high school in Fairfield County, Ohio whose parent(s) served or are serving in the U.S. military.

Officer Brett Markwood – to provide scholarships for Fairfield County students to attend a police academy, technical school for law enforcement training or four-year college in a law enforcement-related field.

V. Ben Martin Scholarship Fund – for graduates of a Fairfield County high school.

Clark M. McGhee and Carol T. McGhee – for students who are residents of Rushcreek Township for at least 12 months or have or will be graduates of Fairfield Union High School or have been residents of Fairfield County for at least 12 months.

Randy E. Miller – to provide financial assistance to Pickaway/Fairfield County students pursuing EMT/Firefighters degree/training or for a degree in music education.

Ruth E. Elizabeth "Libby" Murry – scholarship recipient shall be a graduating senior or graduate of Jonathan Alder High School, Plain City, Ohio. The recipient shall pursue a degree in the study of Education and/or excel in the field of science. Awards may be made for any four-year or two-year accredited college.

Roger Pedigo Memorial – for the purpose of providing educational scholarships for selected high school seniors from Athens, Hocking, Vinton, Fairfield and Franklin counties who are furthering their education by attending Ohio University in the following manner: Applicants must have maintained a high school GPA of 3.0 or above. Applicants must possess leadership skills and have participated in community service work. Special favor will be given to applicants whose families will exhibit financial hardship through the funding of their child's furthering education.

William D. Queen – to benefit students from Fairfield Union. Special consideration is given to candidates majoring in math or computer sciences.

LaVerne Raab – for graduates of Fairfield County High Schools for undergraduate tuition and expenses.

Stori Huston Raver – to provide scholarships for a graduating special education senior from Fairfield Union High School. The scholarship may be used for a two-year or four-year college, vocational school, technical school, apprenticeship or for support upon entering the work force.

Gladys M. Reber – to provide scholarships for students at the Maple Street United Methodist Church.

Kathleen Kaser Ridenour Memorial – to be used for the purpose of providing scholarships Perry county residents. Applicants must be 9th grade students at the Sheridan Middle School with career interests in becoming a teacher, to be used once they graduate high school and are enrolled in college.

Kathleen K. Ridenour Memorial – for the purpose of providing educational scholarships for Sheridan High School seniors with a 2.2 or higher GPA., who have obtained a letter of recommendation from a Sheridan High School teacher, and have completed the application fully.

Robert Rowles Family Fund – to provide educational scholarships for students who are residents of Fairfield County, who are graduates of Fairfield Union High School, are enrolled in a post-secondary program, and have a financial need which might keep them from otherwise attending college.

The Rushcreek Grange – to provide scholarships for graduates of Fairfield County high schools who are residents of Rushcreek Township for at least 12 months prior to application. The recipient must be alcohol, tobacco and drug free. May be awarded for any four-year, two-year or technical college.

Mollee J. Seifert – for graduating seniors from Fisher Catholic and Lancaster High Schools seeking advanced education at an accredited institution.

Shaner-Wohrer Memorial Scholarship – the purpose of this fund is to provide \$100 college scholarships to graduating senior girls' volleyball students, from Lancaster High School, in Fairfield County.

Richard F. Shannon – scholarships to Ohio University Athens and Ohio University Lancaster for graduates of Lancaster High School. Priorities given to students whose parents are deceased, single-parent families and low-income families.

Tyler C. Sharpe Memorial Scholarship – to provide a scholarship(s) to a graduating senior within the Muskingum Valley League (MVL) residents, pursuing a university degree. Recipient must compete on his or her high school Cross Country team and display academic excellence with a 3.5 GPA or higher.

Russell N. & Clarice H. Stemen – to provide scholarships for post-high school students who are members of the Calvary United Methodist Church or the Bremen Bethel Presbyterian Church of Bremen, Ohio, for at least three years preceding their senior year in high school. Selection shall be based on financial need. May be awarded for a four-year, two-year vocational or technical college education.

Dr. Thomas E. Stenger – for the purpose of providing educational scholarships for graduates of William V. Fisher High School. Preference is given to students pursuing a degree in the health care field and to students with good academic standing.

Ryan Stoneburner Memorial Scholarship Fund – to provide a scholarship(s) to Amanda- Clearcreek graduates pursuing a university degree in Physical Therapy.

Each year in October, the Fairfield County Foundation makes a significant donation to area food pantries to help them meet the basic needs of local citizens throughout the year, and especially during the busy holiday season. GRANT PROFILE

New Signage Increases Visibility of Downtown Museum

The beautiful, new signage that illuminates the front entrance of the Ohio Glass Museum downtown is a project that was in the making for nearly ten years. The need for the sign was born out of a conversation had by former art director Jed Janeri at Four Reasons Café across the street from the museum. After mentioning to fellow customers that he worked at the museum, they asked where it was. Troubled by the fact that downtown regulars who happened to be right across the street from the museum at the time weren't even aware of its existence, he immediately went back to the museum and told his former assistant Anne Hart Kiphen, now the current art director for the museum, that new signage for the front entrance needed to be a priority.

"It took 10 years, but we finally got people convinced we could apply for a grant for that," said Kiphen. "The Fairfield County Foundation provides an invaluable service to the community. They are truly there to help you through every step of the process, and in the end, small non-profits like the Ohio Glass Museum are able to fund improvements that have significant impact on our organizations and the community."

The Ohio Glass Museum received a \$10,000 grant from the Terry McGhee/Sally Grimm Community Fund to design and install a new, art deco style sign with lighting behind each letter. Claypool Electric did all of the design and installation work to ensure compliance with the Historic Lancaster Commission guidelines. The end result is an illuminated sign that will catch the attention of passersby and serves to enhance the downtown landscape.

Q: Why did you choose to set up your funds through the Fairfield County Foundation?

We are true believers in supporting the local community. We buy local whenever possible. We eat at local restaurants, and we exclusively support local charities. The Fairfield County Foundation allows us to do this in a very effective way.

We created our scholarship fund in 2012. It is for residents of Fairfield County pursuing a university degree in elementary education or nursing. Two years later, we set up our family fund. We created a donor advised fund to support local charitable organizations. We both recognized that there were many people who helped us along the way and we see both of these funds as our opportunity to give back now that we are in a position to do so.

Q: How has your involvement with the Fairfield County Foundation served as a benefit to you and your family?

The Foundation provides a number of unique pathways for charitable giving, options that aren't available if you were to donate directly to

a charitable organization. We have chosen to fund both of our funds through an annual donation of stock that has appreciated in value. If we were to sell the stock, we would be required to pay capital gains tax. By depositing the gains into our funds, we avoid those taxes and instead receive an itemized deduction. Even better, we are able to use that money to benefit local charities and organizations that improve our community. It truly is a win, win, win.

We have come to know a lot of people involved in the Foundation over the years. It's nice to be able to talk with people who share similar priorities and gain insights and new ways of approaching your charitable giving. We also enjoy meeting and getting to know leaders from the local non-profits and organizations that receive funds from the Foundation. It is a great network of local folks who are committed to making our community great.

Q: What do you hope your investment does?

We have supported the Lutheran Social Services Food Pantry at our church for years, both financially and with our time. We can see the benefits of this investment as local families in need receive

nourishment and other supportive resources with each visit to the pantry. You often hear stories about large national charities and how such a significant portion of the donations they receive goes towards administrative costs. With local charities, we know that whatever we give them they will use to benefit people right here in Fairfield County. We are able to see the impact and in many cases benefit from their work.

Q: What is your favorite thing about the Fairfield County community?

Lancaster is a fairly progressive town, with a strong arts culture. We love the Lancaster Festival. There are a number of local music groups that many people don't even know about. The opportunities for families to get out and enjoy unique, cultural experiences are truly impressive for a smaller community. It is also a very caring community, dedicated to supporting its children, the elderly and those who are less fortunate. We want to support these organizations and events and ensure that they can continue to be a part of this community for many years to come.

GRANT PROFILE

Local Families Receive Education and Tools to Encourage Healthy Lifestyles

The Fairfield Community Health Center is a federally qualified health center with three clinics to serve the needs of local citizens. After participating in the Fairfield County Health Assessment with Fairfield Medical Center and other local entities, the center decided to expand their Healthy Steps program from its initial focus on diabetes and chronic disease to include obesity and focus on children and families. The expanded Healthy Steps and Beyond program is designed to serve anyone who wants to learn self-management skills and incorporate lifestyle changes that address chronic disease and reduce obesity.

The center provides education and resources through patient visits, newsletters, social media and their website. In addition, they offer free classes – a daytime class for adults and an evening class for families – where they provide education and resources. Upon completion of each class, participants are given a tool to help them incorporate or maintain these healthy lifestyle changes. Gifts include bathroom scales, blood pressure cuffs, food scales, fitness trackers, jump ropes, fit deck cards, kick scooters, dance ribbons, kick balls, Thera bands, and MyPlates, which display the five food groups and their proper portions on the plate. In addition, participants receive a healthy snack during each meeting along with recipes and unique ways to create healthy foods for the whole family. To help support this program, the center received a grant from the Fairfield County Health Fund for \$10,840.

“This grant from the Foundation has given us a better way to teach the self-management skills that will improve lifestyles for our patients and families, and reduce the risk and complications from developing diseases,” said Mary Lu Bowman, RN Care Coordinator at Fairfield Community Health Center. “Many of our patients simply can’t afford these tools. We are so grateful to the Foundation for helping us better serve our patients and improve the overall health of our community.”

Grants Support Construction of Brand New Children's Museum

Since 2007, AHA! A Hands-On Adventure, A Children's Museum has been providing children and the adults in their lives with a hands-on, interactive, playful and educational environment that invites curiosity, allows exploration, encourages participation and celebrates the child-like wonder in us all. Grimm Community Fund.

The new 8,000 square foot building, designed and built to address all the unique needs of a children's museum, opened on April 23, 2018 to great enthusiasm from the community.

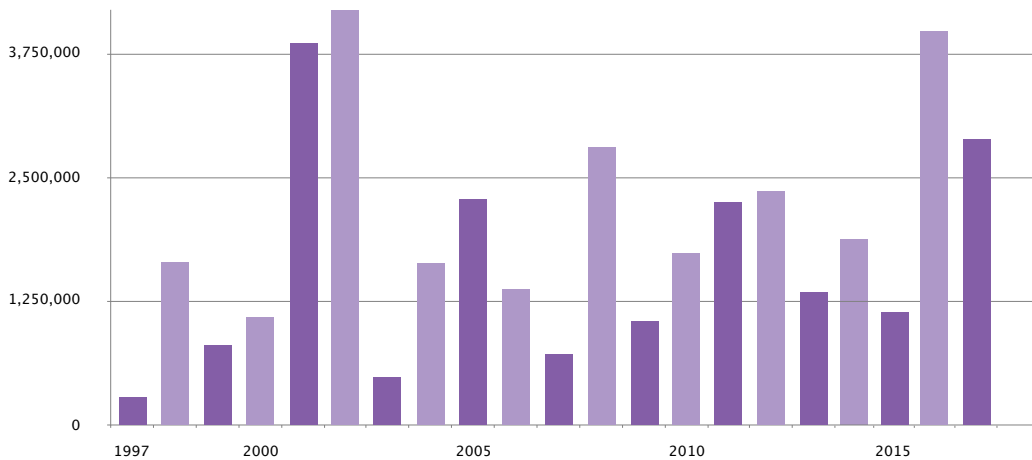

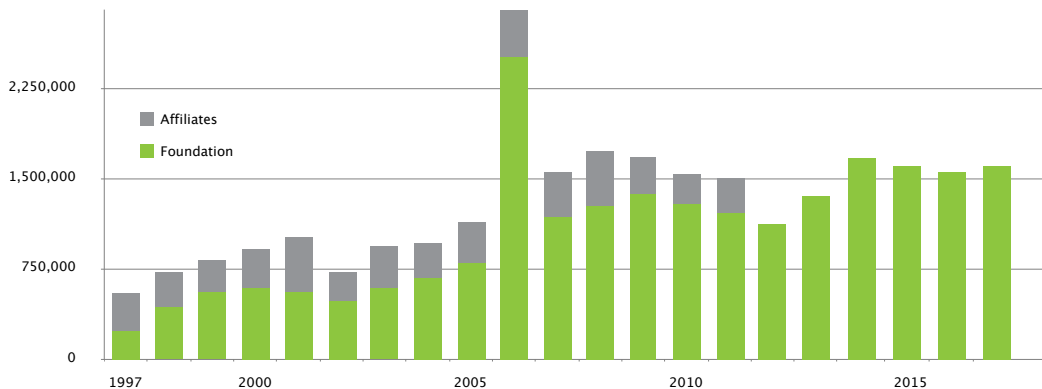

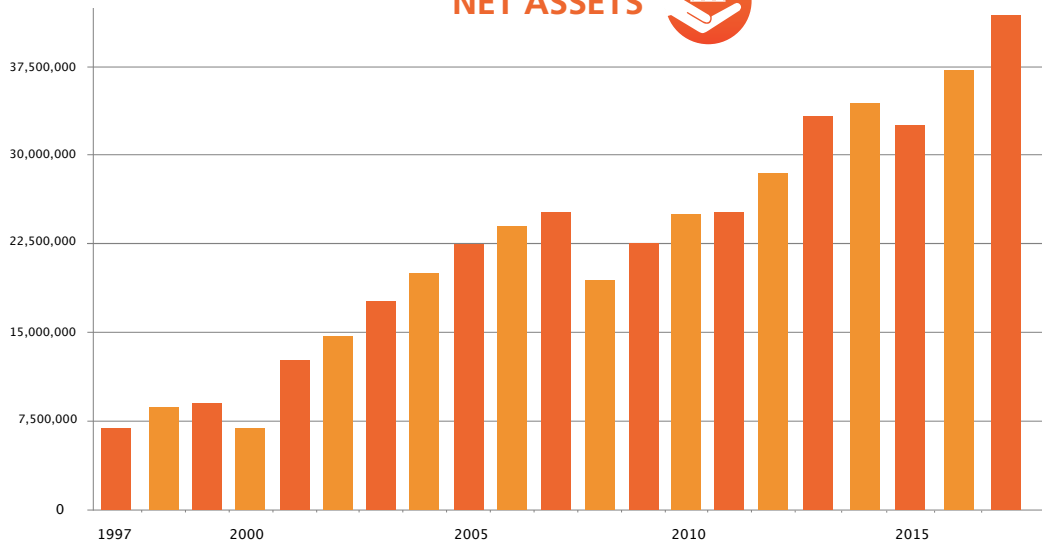
