# Scholarship Application DEADLINE MARCH 12th!

The scholarship application for the 2018-2019 school year is due on March 12th, nearly one month earlier than in previous years! In addition, this year only TWO letters of reference are required. We encourage applicants to give references enough time to upload their letters online before the March 12, 2018 deadline.

Current college students as well as high school seniors are encouraged to apply. Our simple, general <u>application</u> will automatically narrow down the scholarships that each student is eligible for as well as suggest those that may require more information.

# Foundation Awards Grant to Fairfield County Strings & Keyboards

The Fairfield County Foundation recently awarded a grant in the amount of \$4,565 from the Janet S. Crist Fund to Fairfield County Strings & Keyboards. The funds were used to purchase sheet music as well as organization and storage systems to start a sheet music library that will serve as a lending library for public use. At present, approximately 700 different titles of music are available in the library.
