Since the Fairfield County Foundation was established in 1989, our focus has always been on building a legacy that will enable future generations to meet the needs of our changing community. As our community has grown and evolved over the years, the Foundation has grown with it, identifying new and innovative ways to support the diverse non-profits that serve Fairfield County. This focus on serving and improving lives in our community is only possible because of the shared vision and extraordinary generosity of our donors.

Even as economic uncertainties persisted, so did the collaborative spirit of giving in our community. In 2022, we received \$4.1 million in contributions, opened 19 new funds, and granted more than \$2.5 million to non-profits in Fairfield County. The generosity of our donors, fund holders and partners continues to surpass every expectation and inspires us each day to find new and better ways to support this community.

In June of 2022, we wrapped up GIVE 365, the first-ever annual campaign organized by the Foundation. GIVE 365 was created to grow the Community Impact Fund, which was established in 2019 to respond to changing community needs, support innovative solutions to community problems, and enhance the quality of life in Fairfield County. We encouraged our Ambassadors, friends, partners and community members who were engaging with the Foundation for the first time to join the movement for just \$1 a day. Through this campaign, we were able to raise over \$470,000 for our Community Impact Fund. A community foundation is only as strong as the people who join together to make a difference, and we have been truly fortunate to have such a dedicated group of supporters through the years. We will continue to sharpen our focus on understanding the true needs of the community and serve as a bridge between our donors and the many deserving local non-profit organizations that meet those needs. 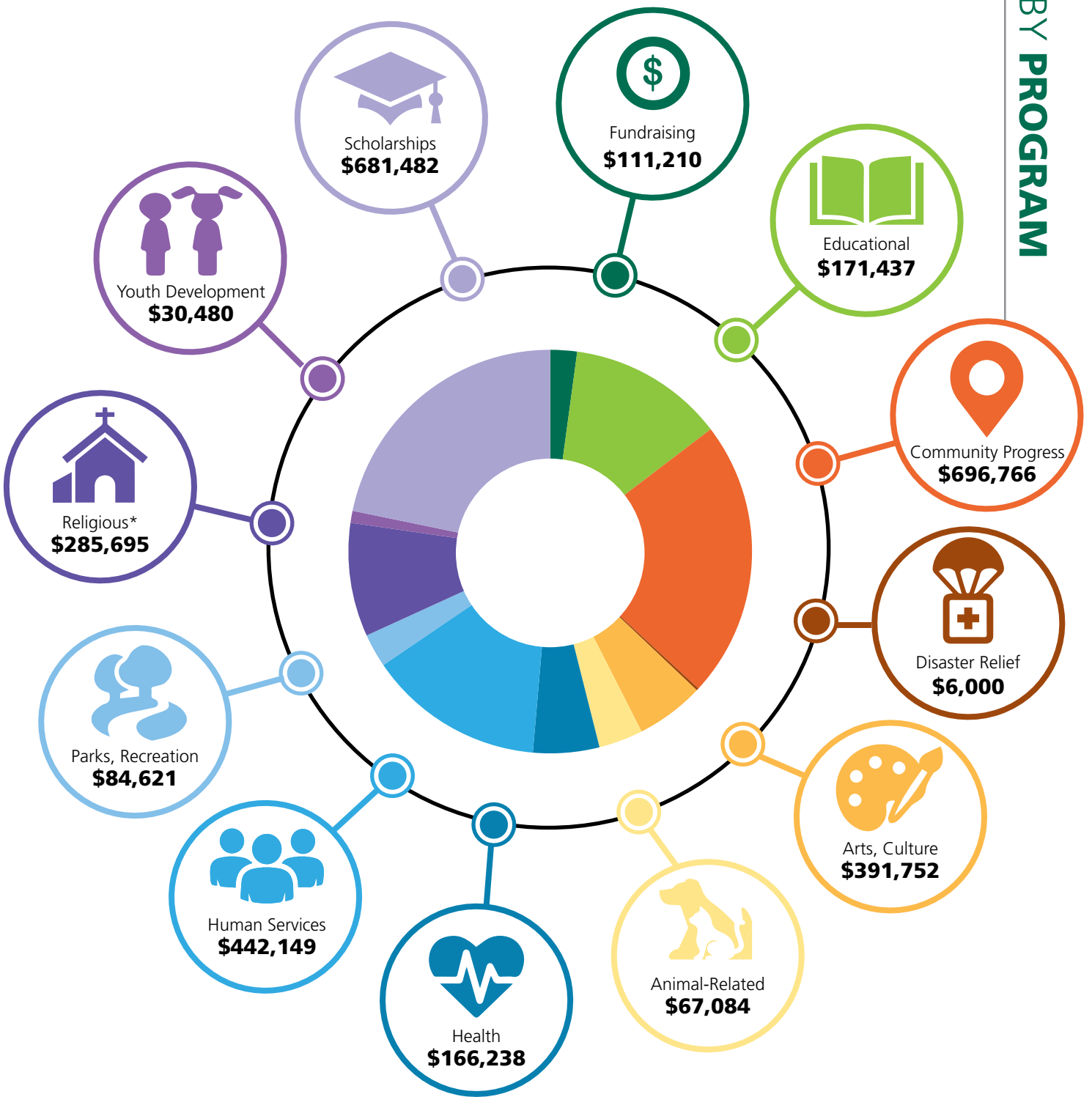

Setting up a Fund with the Foundation

Your Foundation is here to help you build your legacy. We can help you determine your charitable goals, such as deciding if you want family members involved, both now and/or in the future; consider how much involvement you want in selecting the charitable organizations that will receive grants from your fund; and think about how much you want to give in charitable contributions each year and how you want to give it.

We make giving easy and effective, accepting a wide variety of gifts and providing donors with a number of charitable options. Our professional staff has in-depth understanding of the issues, opportunities and resources that shape our community. The Foundation has several options for setting up a fund that best meet your giving goals, including the following:

- **Donor-Advised Funds:** This type of fund enables donors or their designees to recommend grants based on their personal charitable interests.
- **Unrestricted Funds:** Unrestricted Funds are gifts to the Foundation's unrestricted general fund. The principal and income is distributed at the Foundation's discretion in the form of grants to 501(c) (3) organizations. A minimum gift of \$5,000 is required to establish a named fund. Gifts of any amount are accepted into the general fund.
- **Scholarship Funds:** Individuals, families, companies, or organizations can establish Scholarship Funds. Once in place, a Scholarship Fund continues to grow with additional contributions from the original donors, from other contributions, and through market growth. The donor of a Scholarship Fund has the ability to define the scholarship's advisory committee and the guidelines for candidate selection, requirements, and award use.
- **Agency Funds or Endowments:** Agency Funds or Endowments can be created to perpetually support your community service agency. Agency funds hold assets for a charitable organization and distribute the principal or earned income in accordance with the agency's specific instructions.
- **Designated Funds:** Designated Funds are established to ensure that support will be provided to specific eligible non-profit organizations, often organizations that donors have been involved with during their lifetimes. This is an opportunity to leave a lasting legacy in the donor's name.

Making a Gift to the Foundation

A variety of assets can be used to make charitable gifts and there are many ways that you can give immediately or in the future.

- **Cash:** Cash gifts are an easy way to make an impact in your community and allow you to give at any time.
- **Securities:** Securities, both publicly traded and closely held, can be used to set up a fund.
- **Real and Personal Property:** Gifting real and personal property often allows an individual to contribute more than they may have thought possible.
- **IRA/Retirement/Pension Fund Assets:** Retirement assets are most often used as testamentary gifts, creating charitable funds as part of an overall estate plan.
- **Life Insurance:** Life insurance makes it possible to make meaningful gifts to the community.
- **Unique Assets:** Examples might include stamp, coin or art collections, copyrights and patents, royalties, or other unique assets of value.
- **Wills and Bequeaths:** Bequests offer varied ways of giving to the Foundation. Cash securities or other property may be bequeathed in one's will.
- **Charitable Remainder Trusts:** A Charitable Remainder Trust provides life-long income for one or several income beneficiaries, such as the donor and the donor's spouse, and leaves the remainder interest to the Foundation or designated beneficiary.
- **Charitable Lead Trusts:** The income generated from assets placed in a Charitable Lead Trust is paid to the Foundation for a period of years, after which the trust is terminated and the assets are returned to the donor.
- **Charitable Gift Annuities:** The Charitable Gift Annuity can make it possible for donors to assist the community in the future while providing lifetime income for themselves. Upon the death of the donor, the remaining principal is retained by the Foundation to carry out the donor's charitable intentions.
- **Transfer of a Private Foundation:** This type of gift affords many advantages, including lower overhead, staff to assist with charitable goals, and a higher tax deduction for any future gifts, to name a few.

RICH HERITAGE MEMORIALIZED ON NEW SIGN

Allen Chapel, located at 221 E. Walnut St., has a long history in the Fairfield County Black community. The congregation dates back to 1814 and the building itself, which was moved to its current location in 1914, dates to 1869. The chapel recently underwent a significant renovation, including new siding, roof, electrical systems, flooring, and more to ensure it could continue to serve the community for generations to come.

As part of that renovation, and in preparation for the church's participation as a stop on the Heritage Association's guided tour of the Black History Pioneers of Lancaster, the Diversity, Inclusion and Empowerment Fund provided a grant to the Fairfield County Heritage Association to create and install a sign that depicts the rich history of Allen Chapel and the Black community that resided in the Carpenter's Addition neighborhood. The sign, which is placed right outside of Allen Chapel, includes documents, photos, and maps that help tell the story and reflect the rich heritage of the church and the Black citizens of Lancaster.

"We have received a tremendous response to the new sign outside the chapel," said Evan Saunders, pastor of Allen Chapel Church. "We've even had people stop by from out of town because they heard about it and are interested in learning more about the history of the area. I can't thank the Fairfield County Foundation enough for their commitment to this project. It has been humbling to see the community come together to support our renovations and pay tribute to our rich history in Lancaster."

Donor Advised Funds

This type of fund is one of our most appealing charitable vehicles. Donor-Advised Funds make possible several options, such as: making a charitable gift now; the ability to make suggestions regarding which charities you would like to support; setting up a fund through your will/estate; and naming certain people as advisors to your fund. Donors receive both tax and philanthropic benefits in a simple format with a high degree of flexibility.

Barrows Family – to benefit the residents of Fairfield County and other charitable causes.

John and Marcia Baughman Family – to benefit St. Mary of the Assumption Church's special liturgical operating fund, "For the Honor of God;" the Ohio University Foundation via the Baughman Family Scholarship Fund at OU-L; the Fox Family Y's Partner for Youth Fund, and the Fairfield County Foundation's Ambassadors' Fund.

Blue Label/One Write – this fund shall be used for the purpose of benefiting the residents and organizations of Fairfield County.

The **Buckeye Lake Region Community Foundation** – to provide financial assistance needed by the Buckeye Lake Region Corporation to coordinate, manage and execute initiatives that support the Buckeye Lake 2036 Vision and the Buckeye Lake Region Declaration.

Christian Stewardship – to provide financial assistance for charitable causes, not exclusively, but with emphasis on supporting Christian-based efforts such as evangelism, missionary support, and providing for the needy both within and outside Fairfield County.

Judd and Mary Ann Clover – to benefit to the Ohio Department of Natural Resources and Preserves and Crane Hollow, Inc. through grants for environmental education and funds to support educational program operations.

Donley Family – distributions shall be made primarily to charitable organizations which provide services primarily in the area of Pickerington or Violet Township, Ohio.

Charles and Diana Eversole Family – to provide an ultimate benefit to the people of Fairfield County, Ohio, for public, charitable and educational purposes, with special consideration given to the Fairfield Heritage Association and matching funds to the Fairfield Medical Center Foundation.

Gertrude Eyman Memorial – to support St. John's Episcopal Church in Lancaster, Ohio by providing resources for traditional church music, new endeavors

and general upkeep, and to support the Fairfield County Humane Society.

DECORATIVE ART CENTER OF OHIO

The Decorative Arts Center of Ohio (DACO) is a not-for-profit museum presenting major exhibitions, student exhibitions, holiday traditions, public programs, and an evolving decorative arts collection. Doors officially opened in 2000, when the Reese-Peters House and the Wendel Center for Art Education were officially dedicated as the Decorative Arts Center of Ohio in Downtown Lancaster. Today, their vision is to enrich the human experience through the arts with inspiration, passion, and imagination.

DACO received a grant from the Wendel Family Fund to support the “Ohio: The Start of It All” exhibition. The exhibition, which featured award-winning picture book illustrators and their original art from the collection of the University of Findlay’s Mazza Museum, focused on illustrators and books connected to local and state history, offering families the opportunity to explore the various connections between art and humanities. The exhibition included framed art on the walls, graphics with facts and firsts about Ohio, as well as reading stations where families were able to explore the full versions of the books featured on the walls.

Thanks to the support of funders like the Foundation, DACO can address some of the misconceptions or barriers that many modern museums face. With this exhibition, DACO ensured the space was accessible to all through culturally relevant programming and promotional partnerships with schools and libraries to attract a diverse audience from across the county. In addition, the exhibition was free of charge and the supplemental programs were affordably priced to ensure finances were not a barrier. “In my experience, the Foundation really is committed to creating opportunities for people and organizations for the benefit of the community,” said Jason Crabill, Executive Director of DACO. “Their support over the years has been critical to our ability to make art accessible to our community.”



Rodenbaugh Family Advised – to provide funds for charitable and educational purposes, as well as for engineering scholarships.

Wayne Roller Memorial – to provide support for grants and scholarships for students, athletes, coaches, teams and officials.

Wanda Shaner Memorial – to provide grants and/or scholarships to benefit the residents in Fairfield County.

Brian Stoner Memorial – to provide funds to charitable organizations that are eligible to receive distributions. Preference for grants goes to organizations dealing with individuals with special needs. Preference for scholarships goes to individuals with autism, individuals with other special needs, individuals intending to major in special education, and individuals attending culinary school.

Tails and Trails Nature – to provide funds to parks, government entities, or non-profit organizations for projects to expand or maintain horseback riding activities. The trails must be within 5 miles of Fairfield County, Ohio.

Troup Family – to provide funds for charitable purposes in Fairfield County.

Vonnie Cares Community Impact – to provide grants to Fairfield County High School students who have a GPA of 3.0 or higher for the purpose of funding a community project to strengthen community relations, to encourage giving and recognize the kindness of others.

Phil Walker Community – for public charitable and educational purposes to provide an ultimate benefit to the people of Fairfield County, Ohio or to other non-profit organizations at the discretion of the donors.

John and Jamie Weaver – to make grants to charitable organizations for the purpose of benefiting the residents of Fairfield County and other charitable causes.

The Weiffenbach Family – to make grants to charitable organizations for charitable purposes.

Williamson Family – to provide funds for charitable purposes.

Larry E. Woods – to provide funds for public, charitable, and educational purposes.

Scholarship Funds

Scholarship funds help students pursue their academic goals. The donor may define the guidelines for the recipient, the advisory committee, the school and the award itself.

Matthew Acton – to provide scholarships for senior golf athletes of any Fairfield County High School, Canal Winchester High School, Circleville High School, Logan Elm High School or Teays Valley High School. This scholarship is for any accredited college or vocational school.

The Anderson/Black/Community (ABC) Mini-Scholarship – to provide scholarships to two Bloom Carroll High School students, staff members, administrators, or retired staff members who had five years of service to the Bloom-Carroll Local School District to fund a Christian Mission Trip (CMT) or a Christian Mission Project (CMP).

Roger Anderson – for students residing in Jackson Township of Perry County and majoring in education or business.

James L. Barrett, M.D. – to provide scholarship assistance to graduates of a Fairfield County High Schools to attend the University of Cincinnati and major in computer science, geology, physics, chemistry, or mathematics.

Bashore College Trust Fund Scholarship – to provide scholarships for Richland Township residents.

Paul D. Beck – to provide scholarships for graduates of a Fairfield County, Ohio high school who demonstrate academic ability and maintain a 3.5 GPA in high school and a 3.0 GPA in any undergraduate program.

Bloom-Carroll Alumni Scholar Athlete – for Bloom-Carroll graduates who participate in sports and demonstrate academic excellence.

William W. Bolsen Memorial – to provide scholarships for graduates of the Ohio State School for the Blind who wish to work toward a degree from a technical, two-year or four-year college.

Marlowe Brainard – to provide a scholarship for students graduating from Millersport High School who desire to continue their education in the field of Arts or Education.

Jean M. Burdette Memorial – for Lancaster High School graduates for study in the field of Special Education.

Glenn R. Burns Dental Education – for residents of Fairfield County who are seeking a degree in Dentistry, Dental Hygiene, or as an Expanded Function Dental Auxiliary.

James Caple – to provide scholarships for post-secondary studies for Fairfield County residents who pursue a course of study in classical vocal or instrumental performance.

Robert E. & Marion A. Carr – for Fairfield County residents who are pursuing a degree in the study of Nursing and/or Teaching/Education.

Molly Ann Clark Memorial – for students ages 17-25 from Fairfield, Perry, Pickaway, Hocking, Licking, Athens or Muskingum counties demonstrating an interest in community service and volunteerism and are past participants (racers) of the Lancaster Soap Box Derby, past derby queens or have had a family member who either volunteered or served on the board of directors of the Lancaster Soap Box Derby. Applicants meeting the above criteria will be given preference in determining recipients, or a student seeking a degree in substance abuse education may be accepted every even year.

Charles C. & Barbara Claypool – for students seeking educational opportunities in technical fields with a preference toward engineering. Preference given to the children of employees of Claypool Electric Inc. and students planning to attend Ohio Northern University.

R. Brian Cline – to provide scholarships to Fairfield County residents seeking a degree in Engineering from a state-supported school in Ohio.

Deputy Ethan Collins – to provide scholarships for Fairfield County students to attend an accredited school or academy in preparation for a career in Law Enforcement or continuing education in Law Enforcement.

Coney Memorial – for Fairfield Union High School graduates.

Susie McMackin Crook – will be awarded to a student who has registered and been accepted at Lancaster Montessori School.

D.A.R.E. – scholarship recipient shall be a graduating senior from Lancaster High School, William V. Fisher Catholic High School or Fairfield Christian Academy and a graduate of the D.A.R.E. Program who desires to continue his or her education.

Davidson-J.C. Community Service – to provide scholarships to students of Fairfield County who demonstrate an interest in community service through volunteerism. Jaycees and relatives of current or former Jaycees will be given preference in determining recipients.

Jillian Davidson Memorial – this fund was established by family and friends to honor the memory of Jillian Leigh Davidson who died of a rare blood disease in September 2000. This scholarship is awarded to a female senior basketball or volleyball athlete at Lancaster High School. This award is given to the individual selected by the Davidson Scholarship Committee.

Elsie R. McClelland Davis Memorial – for graduates of Amanda-Clearcreek High School.

Jim DePietro – for the purpose of providing educational scholarships for college students in the manner described: 1. Applicant must be a high school senior and a Lancaster Y Swim Team (LYST) swimmer. 2. LYST swimmer must have been a participant of the LYST program for at least two years, prior to application. 3. Seniors wishing to apply will be asked to write an essay, using an essay prompt determined by the (active) LYST Parent Board Committee.

Frank Dillard Memorial/Standing Stone National Bank – for graduates of Fairfield County High Schools. Preference given to biological or legally adopted dependents of Standing Stone National Bank employees. Weighted toward those who plan to major in Business/Finance at Ohio University Lancaster.

Jack and Carol Burton Drugan Engineering Scholarship – for Pickerington Central seniors majoring in Engineering at an Ohio college.

Drummond, Strait & Fisher Mergypsy Tattoo Art Scholarship – for graduating seniors of Lancaster High School who are majoring in Visual Arts (Fine Arts, Photography, Graphic Design, Ceramics, Illustration, Glass Blowing, etc.).

Charles E. Dupler – to provide financial assistance to Fairfield Union High School music and F.F.A. students.

Chad Edwards Memorial – to provide scholarships for Fairfield County students to attend an accredited school or academy in preparation for a career in law enforcement or to further their career in law enforcement.

Leroy and Bernice Ellinger Memorial – for any graduate of a Fairfield County high school or any graduate from a high school in Worthington, Ohio. Preference will be given to a graduate of Lancaster High School. Applicant must be a college junior or senior and preference given to an accredited four-year college. Recipient must have at least a 2.75 GPA going into their junior year.

Explore Me a Story Mindful Nature Preschool Scholarship – for the purpose of awarding scholarships for tuition expenses at Explore Me A Story Mindful Nature Preschool.

Fairfield County Educational Service Center Superintendent's Scholarship – for students within Fairfield County based on academic and athletic achievement.

Fairfield County Medical Alliance Healthcare – for current residents of Fairfield County, graduates of Fairfield County high schools, or individuals employed in Fairfield County who are committed to pursuing a nursing career.

Fairfield Federal Ron Keaton – to provide scholarships for Lancaster High School senior varsity girls basketball players.

Amelia Fickel – Glenn Moodie – to provide scholarships for graduates of Perry-Southern Local School District. Special consideration given to graduates who are residents of the former New Straitsville School District. Selection shall be based on financial need. May be awarded for a four-year, two-year vocational or technical college education.

George and Marilyn Finnen Education – to provide scholarships for Lancaster High School graduates majoring in the field of Education. This fund was established by a gift from George Finnen in memory of his wife Marilyn.

Wilfred and Una Fosnaugh – for residents of Fairfield County, Ohio pursuing a bachelor's degree in education at any accredited educational institution and is need based.

Foundation "45" – for graduating seniors of Logan High School who are in a college preparation program and will attend a two-year or four-year college/university program. It is in memory of Corey Kissling and Mark Potter.

Lynn and Lynda Freisner – to award a scholarship annually to any student, Freshman through Graduate level, but only awarded for a single year for each student. Recipient must be a resident of Rushcreek Township or a member of Bremen Bethel Presbyterian Church (BBPC). In addition, a recipient must be attending either The Ohio State University or Ohio University.

Bleu George Memorial Fund – to help maintain a memorial garden at Valley View Golf Club, as well as to provide one scholarship annually to a graduating senior golfer in Fairfield County.

Lorelei Owen Gibbs – for residents of Fairfield County pursuing a university degree in Elementary education or Nursing.

Patricia Woodyard Gilmore Memorial – to provide educational scholarships for students who have graduated from a high school in Fairfield County and plan to attend a 4-year college or trade school program in Ohio.

The Jack Greathouse Gale Force Basketball – to provide educational scholarships for Lancaster High School seniors who were boys' basketball players.

O.J. Green Memorial – to be used to provide scholarships to the most inspirational senior football player and to one senior Art student at Canal Winchester High School.

Robert V. Grilli Memorial – to provide a scholarship for graduates of Lancaster High School and Fisher Catholic High School who desire to continue their education in a collegiate and/or graduate institution.

Jacob Guisinger Memorial – to provide scholarships for graduates of Berne Union High School. The recipient will be determined based on academic merit, economic need, athletics, and community involvement and must be seeking advanced education at any accredited educational institution.

Nils Gustavson Scholar Athlete – for the purpose of providing educational scholarships for a graduating senior of Lancaster High School with good academic standing and qualities of a scholar athlete. Student must attend an Ohio school.

J. Jay Hampson – for students residing in Fairfield County and attending Ohio Northern University.

Paul E. Harper Memorial – for scholarships for Harper Operating Company employees, children of employees, and grandchildren of employees or to purchase 4-H animals from students at local fairs.

Doug Henwood Memorial – to provide scholarships to Lancaster High School graduates who participate in Track and Field and may be involved in Track and Field at the collegiate level.

William D. Hilyard Family – to be used to reward the outstanding senior music student at Fairfield Union High School. The award shall be known as the "Robert Trocchia Outstanding Music Student Award" given by the Family of William D. Hilyard.

Hocking Valley Dental Society – to provide scholarships for students in Dental Hygiene or Expanded Function Dental Assisting. Students must be a graduate of a high school within the counties served by the Hocking Valley Dental Society (HVDS), Fairfield, Perry, Hocking and Athens, or a resident of one of these counties, or an employee of a dentist in the HVDS.

Billy J. Holbrook Memorial – for a graduating senior of Liberty Union High School.

Home School – for the purpose of providing educational scholarships for home-schooled students applying to attend a 2 or 4-year college.

Henry and Eleanor Hood – to provide scholarship(s) to Fairfield County residents who are graduates of Lancaster High School, have completed the LHS STEM program, have been admitted to an accredited 4-year college or university with the intent to major in Engineering or Bio Medical Sciences.

Joseph and P.J. Hoover Family Trust – this fund is for the purpose of providing an educational scholarship for graduates of Fairfield Union High School for the study of art education or early childhood education.

Larry L. Hoover Memorial – to provide scholarships to college juniors or seniors majoring in Agriculture or a field related to Agriculture.

Hutton Family – for the purpose of providing educational scholarships for the study of Nursing. The recipient shall be entering at least his or her Junior or Senior (year) in college and shall be a resident of Fairfield County.

Johns Family – for graduates of Amanda-Clearcreek High School.

Trevor and Violet Jones Memorial – for graduates of Millersport High School.

The Carolyn L. Joos Memorial – for an academic scholarship for Fisher Catholic High School students.

Robert Knisley Fire Service – for graduates of a Fairfield County high school who want to pursue a career in the fire service and are attending a college pursuing a fire science degree or a vocational school pursuing a state of Ohio certification in a fire or EMS field. Children of present/former Lancaster Fire Department members will be given preference and can be graduates of any high school.

Kenny Kosch Memorial – for graduates of Liberty Union School District who are seeking a degree or certificate from a trade school.

Keith A. Kumler Vocational – for Fairfield County students to attend an accredited vocational or technical school for study in the automotive field.

Norman A. Kushen Pay It Forward Scholarship – for deserving students who have been in custody of Fairfield County Job & Family Services, Child Protective Services, or who are currently in the custody of Fairfield County Job & Family Services or Child Protective Services.

Lancaster Boys Soccer Booster Club – for providing scholarships to deserving Lancaster High School boys' soccer seniors.

Lancaster Camp Ground Quality of Life – for the purpose of improving the quality of life for residents living on the Lancaster Camp Ground. The fund will offer assistance and help defray costs in the following areas: Youth camps such as, but not limited to, church, 4-H, Boy and Girl Scouts; spiritual retreats, mission work, and family camps; and life enrichment experiences for youth and adult residents.

Lancaster Community Chorus – to provide scholarships for students majoring in Music Education, Music Therapy, or Music Performance. Students must be graduates of schools in Fairfield County or counties contiguous to Fairfield County and must have achieved at least sophomore status at their universities and maintained a 2.5 GPA.

Lancaster-Fairfield Chamber of Commerce – for students graduating from a Fairfield County high school intending a career in business.

Lancaster High School Band Boosters – for students graduating from Lancaster High School who have been members of the Lancaster High School Instrumental Music Program for at least three years.

Lancaster High School Class of 1957 Memorial – to provide educational scholarships for Lancaster High School graduates. Recipient must be currently enrolled in or have been accepted into a program leading to a bachelor or associate degree, demonstrate potential for high school or post high academic achievement and show financial need.

Lancaster High School Class of 1959 – this scholarship is for a senior graduate of Lancaster High School. Recipient must not be a recipient of any other scholarship and must be attending a post-secondary

education program and/or a traditional four-year college. This could include community college, liberal arts college, universities, vocational schools, trade schools, institutes of technology or professional schools. Recipient must be a student who, in the committee's opinion, deserves assistance, even though they have not qualified for other scholarships, and the recipient should be involved in school and community activities.

Lancaster High School Class of 1964 – to provide an educational scholarship for a graduating senior of Lancaster High School. Recipient must not be a recipient of any other scholarship at the time of application. Recipient must be attending any post-secondary education program and/or a traditional four-year college. This could include community college, liberal arts college, universities, vocational schools, trade schools, institutes of technology or professional schools. Recipient must be a student who, in the committee's opinion, deserves assistance, even though they haven't qualified for other scholarships. Recipient should be involved in school and community activities.

Lancaster Junior Women's Club – for the purpose of providing educational scholarships to support females who attend a high school, or who are home schooled, in Lancaster and are entering their freshman year in an undergraduate college or university program. Recipients must volunteer in their community for a certified 501(c)3 organization for a minimum 20 hours in the prior 12 months from submitting the application and must have a cumulative GPA of 3.5 or higher on a 4.0 scale.

Lancaster Kiwanis Club – for students graduating from a high school located in Fairfield County, Ohio.

Erik J. Landis Memorial – to provide scholarships for graduating seniors from Fairfield Union High School who will be attending an accredited educational institution. Recipients will be chosen based on academic merit, economic need, and community involvement.

Jamey Landis Memorial – to provide scholarships to Fairfield County high school seniors who participated in track, cross country, or FFA.

Malinda Lifer – for recent graduates of Bloom-Carroll High School or Lancaster High School who plan to major in elementary education at Ohio University Lancaster.

Liberty Union Alumni Association – to provide scholarships for Liberty Union High School graduates.

Frank P. Maguire – to provide scholarships to students who graduate from a high school in Fairfield County, Ohio whose parent(s) served or are serving in the U.S. military.

Officer Brett Markwood – to provide scholarships for Fairfield County residents to attend a police academy, a technical school for law enforcement training, or a four-year college in a law enforcement-related field.

V. Ben Martin – for graduates of a Fairfield County high school who have been accepted to the Fisher College of Business at The Ohio State University.

Clark M. McGhee and Carol T. McGhee – for students who are residents of Rushcreek Township for at least 12 months; or are, or will be, graduates of Fairfield Union High School, or have been residents of Fairfield County for at least 12 months.

Randy E. Miller – to provide financial assistance to Pickaway/Fairfield County students pursuing EMT/Firefighter's degree/training or a degree in music education.

Ruth E. Miller – for the purposes of providing an opportunity for a college and university education for persons from Lancaster and Fairfield County whose financial condition is such that they would not otherwise be able to procure a college or university education without the scholarship. Marlo Mills Memorial Scholarship – for Bloom-Carroll High School graduating seniors who are residents of the Bloom-Carroll Local School District.

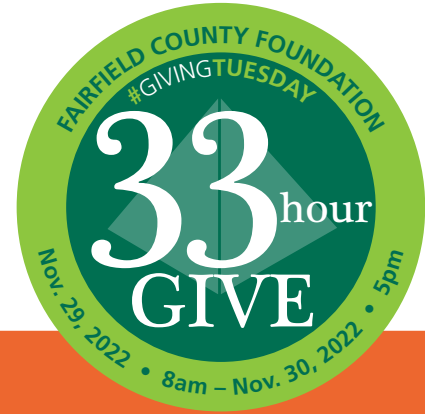
John Morrow Music Booster (Pickerington Music Boosters) – for Pickerington High School graduating seniors who were members of the music program.

FAIRFIELD COUNTY CONTINUES TO ANSWER THE CALL TO “GET YOUR GIVE ON!”

In 2014, the Fairfield County Foundation joined a nationwide effort to raise awareness of community philanthropy called #GivingTuesday, which occurs annually the Tuesday after Thanksgiving. Similar to how Black Friday and Cyber Monday have become days that are synonymous with holiday shopping, #GivingTuesday has inspired people to take collaborative action to improve their local communities, give back in better, smarter ways to the charities and causes they support, and help create a better world.

The Fairfield County Foundation celebrates #GivingTuesday with an annual “Get Your Give On” event, which began as the 25-Hour Give in recognition of the Foundation’s 25th anniversary and has increased by an hour each year, with the 33-Hour Give taking place in 2022. Non-profits and fund holders were encouraged to secure donations from individuals and have them contribute in-person or online during a 33-hour time window that begins at 8 a.m. on Giving Tuesday. During the designated 33 hours, the Foundation matches funds on a pro-rata basis, up to \$33,000.

The annual GIVE events are now widely recognized by donors and non-profits as a simple, highly impactful way to support local needs. The Foundation has raised more than \$1.2 million over the years, with the 33-Hour Give event in 2022 raising an impressive \$256,684! With the Foundation’s \$33,000 match, that’s \$289,684 to participating funds!



Roger Pedigo Memorial – for the purpose of providing educational scholarships for selected high school graduating seniors attending Ohio University who have at least a 3.0 GPA, leadership skills, and community service and are from Athens, Hocking, Vinton, Fairfield and Franklin counties. Special favor will be given to applicants whose families will exhibit financial hardship through the funding of their child's furthering education.

William D. Queen – to benefit students from Fairfield Union. Special consideration is given to candidates majoring in math or computer sciences.

LaVerne Raab – for graduates of Fairfield County high schools for undergraduate tuition.

Stori Huston Raver – to provide a scholarship for a graduating special education senior from Fairfield Union High School. The scholarship may be used for a two-year or four-year college, vocational school, technical school, apprenticeship or for support upon entering the work force.

Gladys M. Reber – to provide educational scholarships for students who have been involved with the Maple Street United Methodist Church.

Kathleen Kaser Ridenour Memorial – to be used for the purpose of providing scholarships to Perry County residents. Applicants must be 9th grade students at the Sheridan Middle School with career interests in becoming a teacher. The scholarship will be awarded once the student graduates from high school and is enrolled in college.

Kathleen K. Ridenour Memorial – for the purpose of providing educational scholarships for Sheridan High School seniors with a 2.2 or higher GPA., who have obtained a letter of recommendation from a Sheridan High School teacher and have completed the application fully.

Robert Rowles Family – to provide educational scholarships for students who are residents of Fairfield County, who are graduates of Fairfield Union High School, are enrolled in a post-secondary program, and have a financial need which might keep them from otherwise attending college.

The Rushcreek Grange – to provide scholarships for graduates of Fairfield County high schools who are residents of Rushcreek Township for at least 12 months prior to application. The recipient must be alcohol, tobacco and drug free. May be awarded for any four-year, two-year or technical college.

S+W Foundation – for students pursuing a degree or certificate in an environmental, science-related field.

Mollee J. Seifert – for graduating seniors from Fisher Catholic and Lancaster High Schools seeking advanced education at an accredited institution.

Shaner-Wohrer Memorial – to provide college scholarships to graduating senior girls' volleyball students from Lancaster High School, in Fairfield County.

Shannon Family – scholarships to Ohio University Athens and Ohio University Lancaster for graduates of Lancaster High School. Priorities given to students whose parents are deceased, single-parent families and low-income families.

Tyler C. Sharpe Memorial – to provide a scholarship to a graduating senior within the Muskingum Valley League (MVL) residents who will be pursuing a university degree. Recipient must compete on his or her high school Cross Country team and display academic excellence.

Jack and Elsie Smith – for Fairfield Union graduates with special consideration given to residents of the former Pleasantville School District.

Johnathan Smith Lancaster Bingo – for children or stepchildren of those employed by Lancaster Bingo Company, Inc.

Sportsmen's Environment & Conservation Association Kenny Stebelton Memorial Scholarship – for graduates of high schools in Fairfield County who are earning a degree involving conservation of natural resources, wildlife, and environment; enhancing and maintaining wildlife environment and habitat; forestry; or agriculture. Students must be their junior or senior year of a 4-year degree program or be in their second year of a 2-year program.

Sophie Strong – to provide scholarships to female, graduating seniors who were members of the Amanda-Clearcreek girls' softball team in good academic standing and to female graduating seniors of other Fairfield County, Ohio high schools who were also members of their high school's softball team in good academic standing.

Russell N. & Clarice H. Stemen – to provide scholarships for post-high school students who were members of the Calvary United Methodist Church or the Bremen Bethel Presbyterian Church of Bremen, Ohio for at least three years preceding their senior year in high school. Selection shall be based on financial need. May be awarded for a four-year, two-year vocational or technical college education.

Dr. Thomas E. Stenger – for the purpose of providing educational scholarships for graduates of William V. Fisher High School. Preference is given to students pursuing a degree in the health care field and to students with good academic standing.

Ryan Stoneburner Memorial – to provide a scholarship(s) to Amanda-Clearcreek graduates pursuing a university degree in Physical Therapy.

Steven E. Svoboda – to provide educational scholarships for students pursuing a degree in the field of technology with special consideration given to students studying Engineering or Auto Mechanics.

Hannah E. Thrash – to provide scholarships to enhance excellence in music with an emphasis on voice. Eligible applicants must be a resident of Fairfield County and should have exhibited a preference for and an interest in vocal music by the applicant's high school activities.

Andrew "Drew" Townsend-Engle Memorial – to provide scholarships for senior choir students at Lancaster High School who have a passion for singing and performing and intend to major in Music.

Kenneth D. & Zita M. Trimmer – 25 percent of this scholarship will help students from Fisher Catholic High School pursue a bachelor's or associate degree in nursing in an approved nursing program. The remaining 75 percent will be used for graduates of Fisher Catholic High School or Lancaster High School to pursue a bachelor's degree from any approved college or university in Business Administration or a master's degree program in Business Administration from Harvard University.

Wilbur O. Turner and Anita M. Turner and Mildred L. Hatter and Frank H. Hatter – for scholarships and tuition assistance for graduates of Lancaster High School who attend seminary school or pursue a career in the medical profession.

Violet Grange #1949 – for students graduating from the Pickerington Local School District or any student who lives in the Pickerington Local School District but attends high school for the purpose of enrolling in a Vocational Agricultural program which is not available in the Pickerington schools.

D. Eugene Ward Memorial – for scholarships for Fairfield Christian Academy seniors who are in the college preparation program who will attend a two- or four-year college/university program. Students will be chosen based on academic merit, high motivation, hard work, Christian moral values, love of family and country, and their contributions to their school and community.

Dr. Martha Gesling Weber – for Fairfield County high school graduates. Preference given to students enrolling at Bowling Green State University majoring in education with emphasis on course work leading to certification as a reading specialist.

Weis Family – for Fairfield County residents who are or will be graduates of high schools in Fairfield County and will be or are attending Ohio University Lancaster for their first two years of college.

Chad Welch Memorial – for Liberty Union students who have excelled in athletics and academics.

Dorothy J. and William W. Wharton – scholarships for students graduating from Fairfield Union High School who will be attending a university in Ohio. Recipients will be chosen based on academic merit, character, personality, leadership potential, and financial need.

Chris White Memorial – for scholarships for graduates of Millersport High School.

Charles T. Wilkins – for scholarships for residents of city of Lancaster or Fairfield County.

Colonel Robert G. Wilkins – to provide scholarship funds that will promote and encourage young adults to pursue a career in the field of aviation.

Edgar A. Work, Sr. – for scholarships for students of Fairfield County. Special consideration will be given to those students who will be attending the School of Engineering at Purdue University.

Rotary Scholarship Funds

In 1992, the Lancaster Rotary Club turned over the investment and administrative responsibility of the Rotary Scholarship Funds to the Fairfield County Foundation. The Lancaster Rotary Club is responsible for setting policy and maintains the selection process for the various Rotary scholarships.

Eva G. Eyman – for Fairfield County graduates planning to attend an Ohio University campus for undergraduate studies. Preference is given to families who show financial need and awards for post-graduate study outside the state of Ohio will be considered.

Bess H. Floyd Cultural Arts – for Fairfield County residents who were active in the cultural arts through their high school activities and are majoring in the Arts.

Bess H. Floyd Music – for Fairfield County residents who exhibit an interest in music through their high school activities and are majoring in Music Vocal, Music Vocal Classical, or Music Instrumental Performance.

Dr. Phil Floyd Dentistry – for Fairfield County graduates going into the field of dentistry, including dental hygiene.

Jerry Floyd Memorial – for Fairfield County residents majoring in Architecture, Landscape Design or Interior Design.

Fannie M. Howe Nursing – for graduates of a Fairfield County, Ohio high school pursuing a career in Nursing.

Lancaster Rotary Club – for students graduating from a Fairfield County, Ohio high school.

Dr. Paul & Mary Magnuson – for Fairfield County graduates pursuing a professional degree in the field of Medicine, Dentistry, Optometry or Nursing.

Jim and Sarah Miller Scholarship – for scholarships to students who have graduated from a high school in Fairfield County, Ohio; who have been accepted to, or are currently attending, Law School; and who can show proof of community service.

Nauman Sampson Wittenberg – for students who have graduated from a high school in Fairfield County and are, or will be, attending Wittenberg University.

Pillar Family Scholarship – to provide scholarships for Fairfield County residents to attend college, a trade school, or trade program, preference given to adoptees and veterans.

Rodenbaugh Family – to provide funds for charitable and educational purposes, as well as for engineering scholarships.

George A. Sakas Memorial – for engineering scholarships for graduates of Fairfield and Perry counties. Preference given to biological or legally adopted dependents of Sakas, Inc., employees and for those who plan to attend a school in Ohio.

Jacob Sims – for scholarships for students who plan to attend Ohio University Lancaster their freshman year and are residents of Fairfield County.

CONCRETE ORKIDZ FOUNDATION

The Concrete Orkidz Foundation, based in Pickerington, was founded in 2019 by Precious Milton with a mission to engage, empower, and equip the students they serve. The nonprofit was granted funds from the George and Dollie L. Zimpfer Memorial Fund, to help support After-School and Summer Camp Programs for children ages six to 16 who reside in economically challenged, one-parent households. The grant funding allowed the organization to purchase laptops and rent two vans that were used to provide transportation during the summer.

The After-School Program serves youth five days per week, providing after-school snacks and meal packs, adult supervision, tutoring, access to high-speed internet, and mental-health counseling. Students have access to laptops, the internet, and the supplies they need to complete their homework or group assignments. The Youth Summer Camp Program keeps students busy during the summer months. Thanks to the vans rented with the grant, students had the opportunity to extend their learning and experience activities such as the Columbus Zoo, COSI, amusement parks, Indian Caves, public parks, and more.

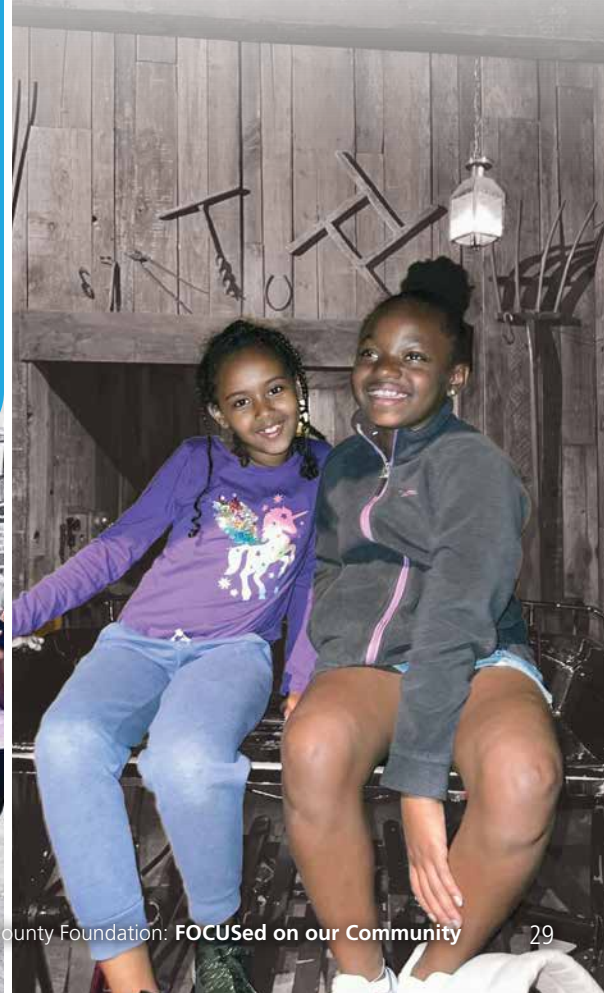
The After-School and Summer Camp programs, which currently serve 25-30 kids, offer critical support and improve the students' mental health and overall well-being. They also relieve stress and burden from the parents and families in need.

YOUTH ADVISORY COMMITTEE

PROVIDES LEARNING OPPORTUNITIES FOR FUTURE LEADERS

The Fairfield County Youth Advisory Committee was established in 2019 to empower Fairfield County high school students through leadership and community service. Participants have the opportunity to learn about projects and organizations that support initiatives for youth in their own communities and gain real-world experience, with responsibilities for reviewing submissions, completing site visits, and presenting recommendations to the Board of Trustees. The committee, which changes each year, is made up of juniors and seniors from across the county. Ten of the 11 Fairfield County High Schools were represented on the committee this year.

The Foundation's Board of Trustees and the Youth Advisory Committee of 2021-2022 awarded grants totaling \$15,154 to 10 organizations to benefit youth in Fairfield County.

The Fairfield County Foundation and Destination Downtown Lancaster conceptualized and hosted the first-ever 250 Plates Community Meal in September 2019, to benefit Fairfield County food pantries and Keller Market. The event is located in the unique setting of Bank Alley in downtown Lancaster and features an inspired menu of locally-sourced food prepared by the chefs of participating downtown restaurants, a cash bar and live music. Volunteers and students from the Lancaster High School Culinary Program delivered the family style entrees and sides while guests mingled with friends and neighbors seated at a long table that extended the length of the alley. The event has raised more than \$52,000 for local food pantries and the Keller Market House since it started in 2019.

Amanda Stuckey, a 2021 graduate of Virginia Tech, is an architectural associate with a passion for creating highly functional spaces. This requires a keen attention to detail and a unique ability to ask the right questions and really get to know her clients.

Amanda attended Fisher Catholic until her senior year, when she transferred to Lancaster High School. She first learned about the Foundation scholarships during a presentation the Foundation gave to juniors at Fisher Catholic and was encouraged by her mom to apply. She received two scholarships her freshman year, the Bess H. Floyd Cultural Arts and the Jerry Floyd Memorial Scholarships. She also received the Jerry Floyd Memorial Scholarship, which is designated for Fairfield County graduates going into the field of architecture, landscape design, or interior design for the following four years of college.

"The Foundation scholarships, really, are what allowed me to go out of state to Virginia Tech," Amanda said. "I'm not sure that would have been feasible without them."

In addition to relieving stress and allowing her to pursue her desire to attend Virginia Tech, the Foundation scholarship process also provided her with connections that would prove quite valuable when searching for her first job in architecture.

"The chair of the scholarship committee at the time, Steve Luchtenberg, is a partner with VPL Architects in Lancaster. I had interviewed with him during the scholarship process, and he later helped me secure my first job with VPL Architects," Amanda shared. "The experience was beneficial in so many ways. I highly encourage all high school students to take advantage of this incredible opportunity!"

BRINGING WOMEN TOGETHER TO MAXIMIZE IMPACT AND BUILD CONNECTION

The Women's Giving Circle, a component fund of the Fairfield County Foundation, is a volunteer-led and member-managed giving circle whose main purpose is to connect, invest, and inspire hope for youth and women in Fairfield County by awarding grants to local non-profits. No volunteering, no event planning, no silent auction donations to solicit. Through collaboration and relationships developed in the circle, the women create a greater impact than they may otherwise have alone.

The Women's Giving Circle meets three times per year for a one-hour meeting and each member is asked to contribute \$100, making the total annual contribution \$300. These meetings bring women together to learn more about issues impacting women and youth in our community and generate the resources utilized to address the unique needs the group decides to support.

This year, the Women's Giving Circle provided grants to AHA! A Hands-On Adventure A Children's Museum for clean-up of its outdoor garden area, Ryan's Rave to Save - Signs of Suicide Program in partnership with New Horizons Mental Health Services, and Connexion West for its Mentor Program.

Since its establishment in 2019, the Women's Giving Circle has disbursed grants totaling more than \$61,875 to the following local organizations:

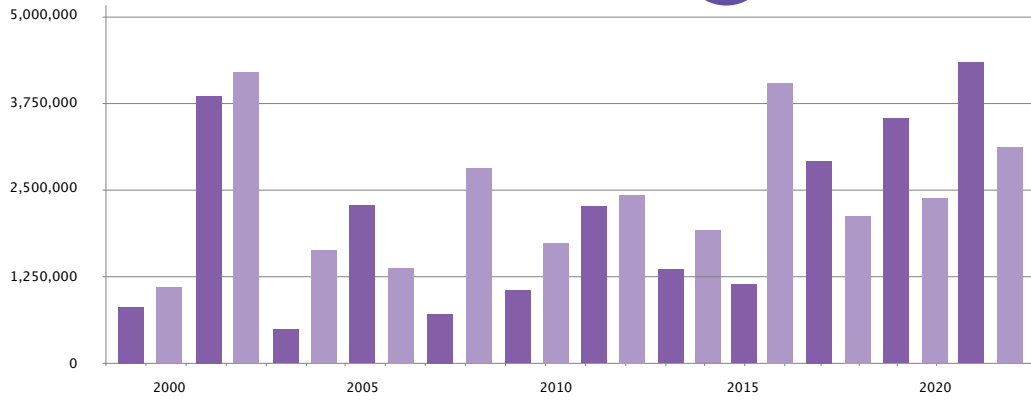

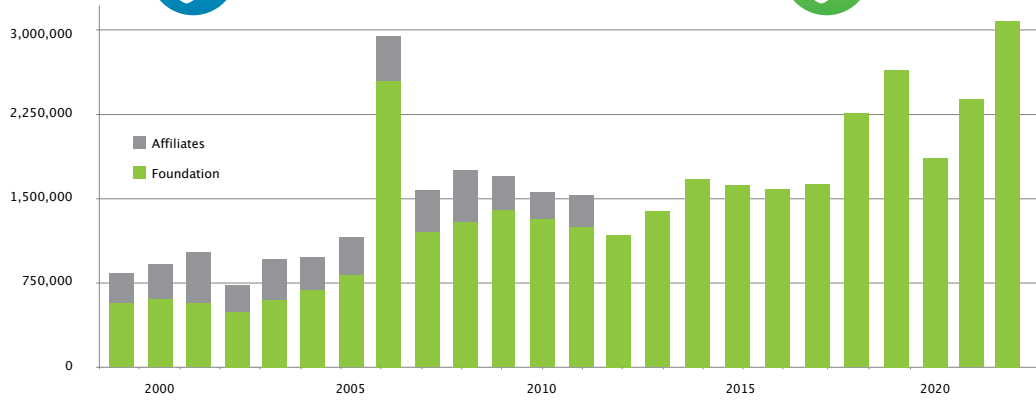

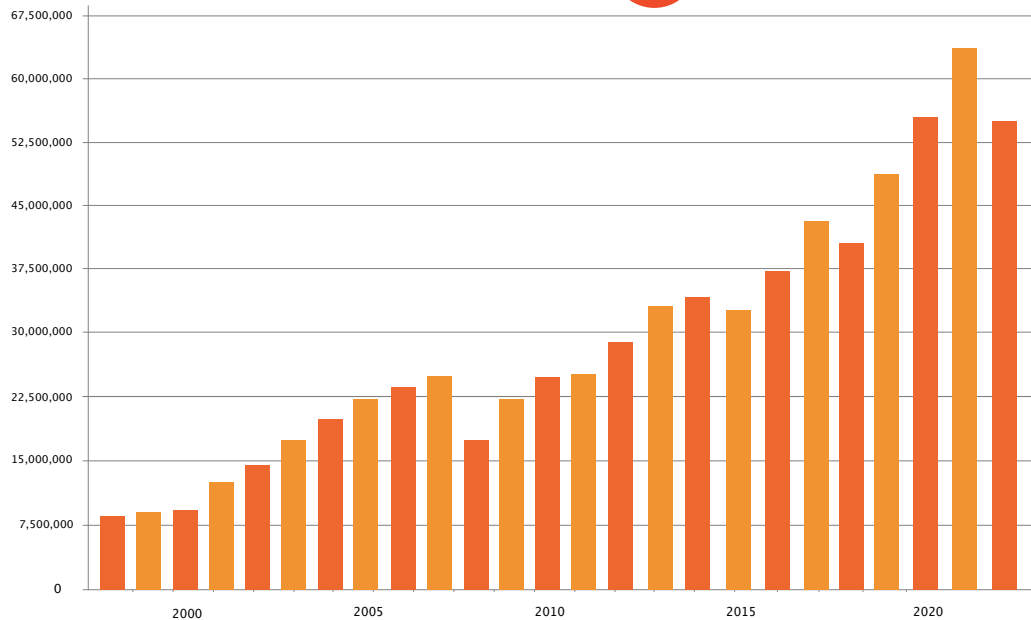
