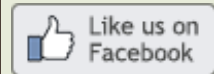

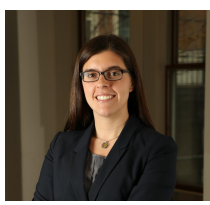
Lynn Barboza completed her associate degree in nursing at Grace Hospital School of Nursing. Lynn is a registered nurse with 30 years of experience in trauma, emergency and intensive care as well as interventional radiology and out-patient radiology. Throughout her nursing career, Lynn worked for Grace Hospital in Detroit and in Columbus at Doctors Hospital and Grant Hospital. Lynn is a nine-year member and two-year president of the Cameo League, a volunteer group of women dedicated to fundraising for the

Lancaster Festival. In addition, Lynn is a dedicated board member for the Lancaster Festival Board of Directors and recently served on the Fairfield Medical Center Foundation Board. As an extension of her career caring for others, Lynn has spent nine years volunteering for the American Cancer society as a patient advocate.



Eileen Competti earned her Bachelor of Science in Industrial Engineering from the University of Cincinnati. She obtained her Master of Business Administration from Ohio University and completed the Stanford Executive Program at Stanford University. Following a 30-year career, Eileen retired from the former Babcock & Wilcox company.
