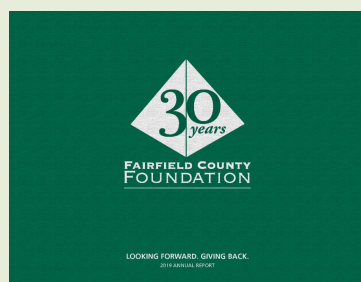

Foundation Announces Third Round of Fairfield County COVID-19 Relief Fund Grants

The Fairfield County Foundation (FCF) and the United Way of Fairfield County (UWFC) recently announced the third round of organizations that received funding from the Fairfield County COVID-19 Relief Fund. This fund was established to provide flexible grant resources, up to \$5,000, to qualified charitable organizations operating in Fairfield County that are directly supporting residents whose basic needs are going unmet due to COVID-19.

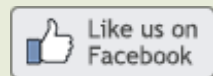

Distributions will be made on a rolling basis as fundraising continues throughout the outbreak and recovery phases of the crisis.
