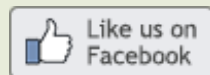

## **Meals on Wheels of Fairfield County Receives Funding for New Home**

Meals on Wheels Older Adult Alternatives of Fairfield County Inc., received two grants from the George and Dollie L. Zimpfer Memorial Fund totaling \$100,000 over a three year period. These funds will help to build a commercial kitchen and provide ADA accessible access as part of their Cedar Heights renovation project.

Meals on Wheels of Fairfield County is a non-profit serving seniors age 60 and older who live in Fairfield County. The organization provides nutrition services and in-home support services that enable independent living and improved quality of life. Meals on Wheels of Fairfield County has operated at the Olivedale Senior Center for over 40 years, but space constraints and an increased demand for services forced them to seek other options. Meals on Wheels of Fairfield County serves more than 2,000 seniors annually.



## What is a Community Foundation?

A community foundation is a non-profit, publicly supported, nonsectarian philanthropic institution with a long-term goal of building permanent funds established by many donors to carry out their charitable interests, and for the broad-based charitable interest of and for the residents of a defined geographic area.
